PUBLIC TENDER ADJUDICATION

All interested parties need to provide proof of identity at the entrance: Only SA National identity document and valid passport will be accepted.

The primary intention in this regard is solely to enable JOSHCO to make the necessary arrangements in respect of suitable capacity and venue coordination.
