- 2.14. "rand value" means the total estimated value of a contract in South African currency, calculated at

The time of bid invitations, and includes all applicable taxes and excise duties;

- 2.15. **"sub-contract"** means the primary contractor's assigning, leasing, making out work to, or employing, another person to support such primary contractor in the execution ofpart of a project in terms of the contract;
- 2.16. **"total revenue"** bears the same meaning assigned to this expression in the Codes of Good Practice on Black Economic Empowerment, issued in terms of section 9(1) of the Broad-Based Black Economic Empowerment Act and promulgated in the *Government Gazette* on9 February 2007;
- 2.17. **"trust"** means the arrangement through which the property of one person is made over or bequeathed to a trustee to administer such property for the benefit of another person; and
- 2.18. **"trustee"** means any person, including the founder of a trust, to whom property isbequeathed in order for such property to be administered for the benefit of anotherperson.

3. ADJUDICATION USING A POINT SYSTEM
