- Stage 1: Prequalification Criteria: The following prequalification criteria will apply:-
  - ✓ The tenderer must be a Level 1 (One) B-BBEE status level contributor;
- Stage 2: Administrative Compliance.
- Stage 3: Functionality Evaluation Criteria;
- **Stage 4:** Preferential Procurement Policy Regulations of 2017 using the 80:20 points system: where 80 points are allocated to price and 20 points are allocated to B-BBEE Level of Contribution
- **Stage 5:** Award Criteria:
  - ✓ Preference for the award will be given to bidders who are at least 51% owned by black people; with special preference to black female ownership
  - ✓ Preference for award will be given to Bidders who reside/ residents of **The City of Johannesburg**.
