It has been assumed that the service provider is familiar with the business of JOSHCO and fully understands its mandate and general day-to-day business activities and what its vision and mission is in terms of providing housing.

2. SCOPE OF WORKS

TERMS OF REFERENCE – APPOINTMENT OF A SERVICE PROVIDERS TO CONDUCT SUPPLIER DUE DILIGENCE AND VERIFICATION

1. PURPOSE

The purpose of this terms of reference is to appoint a professional service provider to conduct supplier due diligence and verification in respect of procurement processes undertaken by the Johannesburg Social Housing Company (JOSHCO).

As part of the of the procurement and evaluation of the tenders, the procurement entity should conduct verification and assurance around the tender's claims and whether it is appropriate for the entity to enter into a contract with the supplier.

2. BACKGROUND

The supply chain management system and processes of municipalities and/or municipal entities must be fair, equitable, transparent, competitive, and cost effective and comply with the prescribed regulatory framework for municipal supply chain management.

JOSHCO has a responsibility to drive financial management discipline including the promotion of a good public procurement system that ensures that JOSHCO complies with the principles of Section 217 of the Constitution, i.e., fairness, integrity, transparency,

efficiency, competition, and equity and provisions of MFMA, related SCM legislation and Treasury instruction notes.

3. OBJECTIVES

Appointment of a professional service provider to conduct supplier due diligence and verification and supplier pre-award verification of the short listed three (3) service providers

The purpose of the services is, amongst others to ensure:

- a) Provide assurance and confidence in a supplier capacity and capability to deliver the goods and services
- b) Verification of Appointment Letters, Completion Certificates & References of the Supplier
