### **1.1. About JOSHCO**

JOSHCO, acting as the agent of the City of Johannesburg (COJ), is inviting proposals from contractors. It has been assumed that the service provider is familiar with the business of JOSHCO and fully understands its mandate and general day-to-day business activities and what its vision and mission is in terms of providing housing.

## **2. SCOPE OF WORKS**

Based on the above; JOSHCO requires a consultants and/or service provider to:

- To ensure continuous collection and management of the utility's accounts for all JOSHCO properties with inhouse vending solutions and to further ensure that we strike a balanced reconciliation of both tenants' unit consumption and the building's bulk meters billing from the City.
- Manage all water & electricity queries logged & replacement of faulty water & electricity meters.
- Monitor regular site visits to all projects & attend to all new metering requests escalated by the Utilities Management Officer.
- Management of the monthly reporting on jobs logged and provide regular feedback on jobs logged to housing management
- Provide solutions for water losses or unaccounted water usage.
- Attend to all escalated customer queries & facilitate testing of meters when queried.
- Utilities documents, reports, and records are accurate, complete, and timely and filed properly
- Daily monitoring managing of online smart water meters.
- JOSHCO will further assume responsibility of ensuring the integrity, accuracy and timeliness of utilities recoveries for each of our projects working together with the appointed service provider for the internal vending system.
- Inspection of water meter readers in our facilities and whether they are linked to Unit numbers or not and report thereof per facility
- Verification of the formula used in each meter reader for calculating usage thereof

- 7. In particular, without limiting the generality of paragraphs 6 above, there has been no consultation, communication, agreement or arrangement with any competitor regarding:
  - (a) prices;
  - (b) geographical area where product or service will be rendered (market allocation)
  - (c) methods, factors or formulas used to calculate prices;
  - (d) the intention or decision to submit or not to submit, a bid;
  - (e) the submission of a bid which does not meet the specifications and conditions of the bid; or
  - (f) bidding with the intention not to win the bid.
- 8. In addition, there have been no consultations, communications, agreements or arrangements with any competitor regarding the quality, quantity, specifications and conditions or delivery particulars of the products or services to which this bid invitation relates.
- 9. The terms of the accompanying bid have not been, and will not be, disclosed by the bidder, directly or indirectly, to any competitor, prior to the date and time of the official bid opening or of the awarding of the contract.
- 10. I am aware that, in addition and without prejudice to any other remedy provided to combat any restrictive practices related to bids and contracts, bids that are suspicious will be reported to the Competition Commission for investigation and possible imposition of administrative penalties in terms of section 59 of the Competition Act No 89 of 1998 and or may be reported to the National Prosecuting Authority (NPA) for criminal investigation and or may be restricted from conducting business with the

public sector for a period not exceeding ten (10) years in terms of the Prevention and Combating of Corrupt Activities Act No 12 of 2004 or any other applicable legislation.
