BACKGROUND INFORMATION

Background

The Johannesburg Social Housing Company (JOSHCO) is a Municipal Owned Entity (MOE) established by the City of Johannesburg (COJ) in November 2003 to provide affordable, well-located rental housing and contribute to reducing the City's housing backlog. Accredited by the Social Housing Regulatory Authority (SHRA), JOSHCO accesses both SHRA subsidies

and the City's Capital Expenditure (CAPEX) budget to develop, maintain, and manage social and affordable rental housing.

JOSHCO currently manages approximately 7 202 rental units, comprising 4 251 social housing units and 2 951 affordable rental units.

The entity is also mandated to provide and manage student accommodation, responding to the growing demand for safe and affordable rental opportunities for students in Johannesburg with 124 beds currently being managed.

The entity operates the student accommodation through a 3rd party and also have a joint venture offering rental accommodation.

The JOSHCO has for years maintained an unqualified audit opinion with material findings reported on the annual financial statements. The material findings are concentrated on commitment disclosure, contract register, related parties' disclosure, UIFW disclosure, cash flow amongst others.

To achieve this outcome, JOSHCO requires professional assistance from a firm of experienced external service providers who will produce the annual financial statements and perform the review of the new GRAP 104 (the preparations will be done inhouse through the City of Johannesburg) for the financial year ended 30 June 2026.

The following systems are used by the entity:

- SAGE – Financial system
- Caseware – for financial reporting
- MDA – For rental billing and age analysis

Project Purpose

The entity aims to improve the audit outcome above by producing and submitting the annual financial statements that are free from material errors to the Auditor General of South Africa (AGSA) on the 31st of August 2026.

Project Scope & deliverables

Prepare and produce credible annual financial statements in compliance with GRAP, MFMA, National Treasury's requirement, Instruction notes and directives issued by the Accounting Standard Board for the 2025/26 financial year with focus on the following amongst others:

- Review and update of prior period error journals and related disclosures
- Review and update the opening balance balances and related disclosures per GRAP 3.
- Review and update the accounting policies in accordance with GRAP and ensure that they have been applied appropriately and consistently.

- Review supporting schedules to the annual financial statements, the general ledger, and the trial balance – The schedules must align to the mapping on CaseWare, and the annual financial statements face and related disclosures.
- Review and update the joint the entity's joint share of the joint venture
- Review and update the accounting treatment of the entity's share of the results of the student accommodation managed by a 3rd party service provider
- Review and update the relevant tax treatment of the transactions (income tax, Vat etc.)
- Ensure the findings raised by the Internal auditors on the interim annual financial statements are addressed.
- Ensure the audit findings raised by AGSA in the previous annual financial statements are addressed with special focus on commitment and contract register workings and related disclosure.
- Preparations of cash flow workings and related disclosures.
- Review and update disclosure required by GRAP 104 based on the workings to be received from an expert Service Provider appointed by City of Johannesburg.
- Review of debtors and creditors age analysis including calculations of debt impairment and write offs.
- Provide support on technical accounting issues that may arise during the period of compilation of the annual financial statements and during the audit
- Segment working preparations and disclosure in the annual financial statements.
- Recalculation of depreciation and provision for doubtful debt
- Assessment of useful lives of the assets in accordance with GRAP (verifications conducted in-house) - some assets are fully depreciated.
- Workings for re-assessment of useful lives
- Skills transfer to officials involved in the section (closed-out report on skills transfer and/or interventions required including templates to be used by the entity going forward)
- Any other related assignments as allocated by the Chief Financial Officer.
